AGREE TO:

1. Not to use drugs or alcohol in any form during my stay.
2. Not to bring or be party in bringing drugs of alcohol onto the premises.
3. Not to get involved in sexual or romantic relationships with clients, ex-clients or staff.
4. Not to use or threaten to use violence against, myself, property, or other people.

I realise that should I break any of the above rules, I am placing my fellow residence lives at risk and will immediately agree to leave treatment of my own accord, failing which, I will be asked to leave EDEN RECOVERY CENTRE by management and counsellors. This is my recovery and I am here for myself, but I understand that I am part of a therapeutic community and there are certain expectations in that regard in order for the community to function.

- I therefore agree to show willingness to participate in all group activities.
- I will be punctual for all NNM, groups and curfews.
- I will be dressed and ready by 07h30 (Mon-Fri and 08h30 (weekends)
- I will clean up after myself at all times, make my own bed and keep my bedroom tidy.
- I will maintain an attitude conducive to recovery and have consideration for other people's feelings, wellbeing, comfort, peace and serenity.
- I will maintain a socially acceptable level of personal hygiene, appearance and behaviour.
- I will keep the channels of communication open and be accessible to everyone.
- I will keep the kitchen clean at all times.
- I will smoke in designated areas only.
- I realise that men and women may not enter each other's bedrooms.
- I will not associate myself with any place or person viewed by management, staff and counsellors as being detrimental to my recovery.

Should I become aware of the above agreement being dishonoured in any way, by a client or ex-client, I realise that it is my responsibility to inform a Counsellor or Senior Resident. I am aware of the gravity of the consequence of my failure to honour the above agreement. I must take my recovery seriously. I am aware that my disease could be fatal.

CONFIDENTIALITY

These terms and conditions as well as the treatment, interactions and communications of whatsoever nature between EDEN RECOVERY CENTRE and myself are strictly confidential and shall not be disclosed by either of us in any manner or form, directly or indirectly, to any person or entity under any circumstances, barring those permitted by the laws of South Africa.

The aforesaid confidentiality undertaking shall be binding upon me as the patient as well as any members of my family, my friends or any other of my associates who are in any way involved through me with EDEN RECOVERY CENTRE.

NON-PUBLICITY

Neither I as the patient nor any of my family or associates shall disclose any information, events or circumstances in any manner or form, directly or indirectly, regarding EDEN RECOVERY CENTRE to any person or entity that would potentially or directly harm the reputation of:-

- Eden Recovery Centre
- The directors, employees, agents or representatives of Eden Recovery Centre
- Any aspect of the treatment methods at Eden Recovery Centre

Eden Recovery centre and I and/or my family shall not assist, or cooperate with any person or entity in committing any act which, if committed by either of us, would constitute a violation of this section.
